




High Priority:

- 2. Climate Change Integration into Stormwater Plans/Fees (62% 15r)
- 3. Distributed Energy Project Business Cases and Models (62% 15 r.)


Medium Priority:

- Carbon Budgeting & Carbon Disclosure (33% 8 responses)
- Scan of Revenue Tools Used in other Municipalities (25 % 6 responses)

 Green/Cool Roof Policies (33% -8r.)




4 Transportation – maximizing GHG reductions + co-benefits (policy/practices)

- First and Last km to/from public transit (research and scan) (29% -7r.)




High Priority:

- 1. Links between: Community Livability/ Economic Competitiveness/ Climate actions (79% -19r.)
- 2. Increasing integration of co-benefits and equity into climate action/community energy plans (69% 16r.)
- 3. Increasing transparency (Climate Change considerations in municipal decision making) (66% 16r.)

Medium Priority:

 Improving CAC communications (what climate action looks like in CAC member Jurisdictions) (46% - 11r.)

- 4. Single Use Plastics Reduction (58% 14r.)
