

# SUSTAINABLE PROCUREMENT TRENDS



# **CIRCULARITY & REUSE**

- Transition from linear to circular economy reduces waste and GHG's
- Procurement criteria help create demand for circular content and business models
- TRU Reuse platform facilitated savings of half a million dollars since 2018



# **LOW-CARBON CONSTRUCTION**

- Public sector construction releases 8 million tonnes of GHG annually
- New Federal Gov. standard on Embodied Carbon in Construction
- Low-carbon projects rapidly increasing in number across the country



# **SOCIAL SUPPLIER PORTALS**

- Supplier diversity and JEDI (justice, equity, diversity, and inclusion) on the rise
- Using or creating portals to connect with Social Value Suppliers
- Tealbook, B2GNow, Supplier.io, CAMSC, CCAB, WBE, CGLCC and more!



### **INDIGENOUS PROCUREMENT**

- Increasing procurement with Indigenous businesses and creating opportunities for Indigenous peoples
- Federal target to reach 5% of spend with Indigenous businesses
- Several municipalities engaging with local Indigenous peoples and developing Policies



#### SUSTAINABILITY FOR PROFESSIONAL SERVICES

- Can look for corporate social and environmental practices
- Pre-qualify service providers that meet sustainability criteria
- <u>NSF/ANSI 391.1 General Sustainability</u>
  <u>Assessment</u> for professional service providers



# **SUCCESS STORIES**

#### **OTTAWA LAPTOPS FIND NEW LIFE**

- Sole-source with Social Planning Council of Ottawa (SPC)
- Reuse rather than traditional e-waste recycling services
- Refurbish and distribute laptops and desktops to individuals and community organizations in need



#### WINNIPEG E-TRANSIT OVERHAUL

- Funding from Canada Infrastructure Program
- Invested \$33 million to purchase 166 zeroemissions transit buses
- Tender issued for 4 different models and 2 different propulsion systems
- Projected to reduce 1350 tonnes of CO2e / year



#### SASKATOON HONOURS INDIGENOUS HERITAGE

- Bus shelters and bike racks installed featuring Indigenous heritage artwork
- Sole-sources with community groups (Saskatoon Survivors Circle) and local Indigenous artists
- Supports local and honours Indigenous stories, while promoting active and sustainable transportation




#### NANAIMO TACKLES LIGHTING WASTE

- Concerned about waste associated with LED lighting replacement project
- Issued Tender with required criteria:
  - Proof of proper separation and e-waste recycling of old lighting/fixtures
  - No foam packaging for new items
  - Preference for recycled content or wood/paper packaging



#### HALIFAX SOCIAL VALUE IN WASTE COLLECTION

- Social Value Questionnaire (SVQ) required in all bids at or above \$1.25 million
- Applied SVQ for 10 points (90 points to cost) to Tender for waste collection from municipal facilities
- Lowest cost bidder scored low on SVQ resulting in award to Re-Group (scored 10/10)
